CONDITIONS OF ENTRY

Every student will behave in a manner which:

- *Brings credit upon themselves, the hostel and the school.*
- *Does not infringe on the rights of others to live in a peaceable and reasonable manner.*
- *Is in accordance with the school and hostel behavioural guidelines as set out by the Board of Trustees*

Students will be mindful that they may not:

- *Absent themselves from the school premises at any time without the permission of a member of the hostel supervisory staff.*
- *Consume or be in possession of alcohol, illegal drugs of any nature, smoke or be in possession of tobacco or vaping products while under the control of the school or hostel.*
- *Commit a crime liable to legal or court action being taken against them.*
- *Take passengers or be in any vehicle – unless specific permission has been granted by both parents and Hostel Senior Management.*
- *Misuse devices / technology or be involved in any form of cyber-bullying.*
- *Use physical violence, verbal violence, intimidate, bully or harass any other student.*
- *Vandalise or misuse hostel or other student property or belongings.*
- *Invite or allow day students in to the hostel.*
- *Provide false information about their leave or whereabouts to hostel staff*
- *Disrespect or show defiance towards any member of the hostel.*

Hostel students who do not abide by the above directions will be subject to the Hostel Serious Misconduct Guidelines.

BOARDING FEE TERMS AND CONDITIONS

INTRODUCTION

Entry into the hostel is a yearly commitment. Students are accepted in the hostel for the full year.

Accordingly, there will be no refunds of annual boarding fees for early termination of hostel boarding placement. However, in exceptional circumstances, Senior Management may consider an application for early termination on a case by case basis.

Hostel Senior Management, in consultation with the Principal, reserve the right to withdraw a student's placement where the L J Wild Conditions of Entry or the Feilding High School Serious Misconduct guidelines have been breached.

HOSTEL BOND

A \$1500.00 Hostel Bond is payable on acceptance of a 2025 hostel placement.

The Hostel Bond will be retained until the student leaves the hostel.

In cases of early termination of a hostel placement, either by the student choosing to leave or withdrawal of the hostel placement due to breaches of hostel or school conditions and guidelines, the hostel bond will be forfeited up to the amount of any outstanding full year hostel fees or charges. The bond balance remaining after charges are deducted shall then be refunded.

The school will endeavour to refund the balance of the Hostel Bond within a three-month time frame.

Where the hostel placement is withdrawn before the commencement of the academic year, the Board of Trustees reserve the right to retain the bond.

HOSTEL FEES

Hostel fees for 2025 will be \$14400.00. A 5% discount is offered for payment in full at the start of the year. These will be invoiced as follows, with payment by direct debit or other agreed method due by 20th of the following month throughout the year.
